



Black Friday £150 Amazon.co.uk Gift Card Promotion

Your relationship with General & Medical Healthcare (“G&M”).

1.1 These terms of use set out the legally binding contract between G&M and you in relation to the Black Friday £150 Amazon.co.uk Gift Card Promotion (“Gift Card/the Promotion”).

1.2. You will be deemed to accept these terms if you purchase a policy with G&M.

1.3 G&M may make changes to these terms from time to time. The most up to date version will be available from G&M on its website www.generalandmedical.com. You should check the terms regularly and if you purchased a policy after the date of any change it will be on the new terms.

1.4 G&M shall use and take care of any personal information you provide to G&M as described in G&M’s privacy policy, and in accordance with current UK Data Protection legislation, and will not disclose this personal information to a third party without your consent.

2. £150 Amazon.co.uk Gift Card Promotion Rules

2.1 The Promotion is organised by General & Medical Healthcare (G&M), General & Medical House, Napier Place, Orton Wistow, Peterborough, PE2 6XN.

2.2 G&M reserves the right from time to time and at any time to cancel, discontinue, temporarily or permanently, or amend the Promotion or these rules with or without prior notice (including, without limitation, in the case of anticipated, suspected or actual fraud).

2.3 In the event of any dispute regarding the rules, notice or conduct of the Promotion, the decision of G&M shall be final and binding and no other correspondence or discussion shall be entered into.

2.4 Every individual who purchases a private medical insurance policy as a direct client directly from G&M through our website or by telephone from either our Essentials, Everyday, Lifestyle and Elite covers with a minimum monthly premium of above £40.00 will be eligible to receive the Gift Card.

2.5 The Promotion begins at 00:00 on 11th November 2024 and closes at 23:59 on 2nd December 2024.

2.6 The Promotion is for one ‘Gift’ which is a £150 Amazon.co.uk Gift Card.

2.7 The Promotion is available to new customers only.

2.8 You can only claim one Gift Card per household.





2.9 Customers will be entitled to claim the Amazon.co.uk Gift Card once only and following payment of their fourth consecutive monthly premium, or four months after paying an annual premium and not from the date of purchase. Each eligible customer will receive an email from G&M which will contain details of how to claim their Amazon.co.uk Gift Card. Please note emails will be sent to the email address used to purchase the policy.

2.10 If you are eligible for the G&M promotion of an Amazon.co.uk Gift Card where you pay your premium monthly, claims must be made within 30 days from the date of the payment of your fourth consecutive monthly premium and where you pay annually, claims must be made within 30 days after you've been on cover with us for four months (not the date your policy starts). If you do not claim within these 30 day periods you will no longer be eligible to receive the Amazon.co.uk Gift Card. Upon receipt of the email from G&M, at the appropriate time, you will need to follow the instructions contained in the email and confirm your details to claim. Once the customer details have been validated you will be given your Amazon.co.uk Gift Card.

2.11 The Gift Card will be sent by post and G&M accepts no responsibility for the product being lost, damaged or delayed in the post. The Gift Card cannot be claimed retrospectively or used in conjunction with any other offer or promotion.

2.12 Amazon.co.uk is not a sponsor of this promotion. The Gift Card may only be redeemed toward the purchase of eligible products on www.amazon.co.uk or other Amazon stores as designated by Amazon.co.uk. Restrictions apply, for full terms and conditions, see www.amazon.co.uk/gc-legal.

2.13 The Gift Card is non-transferable, non-exchangeable and there is no cash alternative. G&M reserves the right to substitute a product of equal or greater value at any time. G&M accepts no responsibility for any costs associated with the product and not specifically included in the product.

2.14 G&M accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of taking out the insurance policy or accepting the Promotion. G&M further disclaims liability for any injury or damage to your or any other person's computer relating to or resulting from participation in or downloading any materials in connection with the Promotion. G&M accepts no responsibility for entries that are lost, delayed, damaged, misdirected or incomplete or cannot be delivered or entered for any technical or other reason.

3. General Legal Terms

3.1 These terms constitute the whole legal agreement between you and G&M in relation to your entry of the Promotion.

3.2 Nothing in these terms excludes or limits G&M's liability for losses which may not be excluded or limited by applicable law. Subject to this, G&M shall not be liable to you for any loss or damage which may be suffered by you in relation to your entry to the Promotion, including indirect or consequential losses.





3.3 G&M shall not be liable for any failure to comply with its obligations where the failure is caused by something outside its reasonable control. Such circumstances shall include, but not be limited to, weather conditions, fire, flood, hurricane, strike, industrial dispute, war, hostilities, political unrest, riots, civil commotion, inevitable accidents, supervening legislation or any other circumstances amounting to force majeure.

3.4 You acknowledge and agree that each member of the group of companies of which G&M is a part may directly enforce, and rely upon, any provision of these terms. Other than this, no other person or company may benefit from these terms.

3.5 These terms, shall be governed by English law. G&M and you agree to submit to the exclusive jurisdiction of the courts of England to resolve any legal matter arising from these terms.
